(a) Annual Stockholders' Meeting

The Annual Stockholders' Meeting of the Corporation was held as scheduled on 16 July 2019 at the Function Room 7, Top of the Citi, 34th Floor, Citibank Tower, 8741 Paseo de Roxas, Makati City. During said meeting, where the stockholders owning at least a majority of the outstanding capital stock of the Corporation were present and/or represented, the following matters were approved by unanimous affirmative vote:

- (i) the Minutes of the Annual Meeting of Stockholders held on 26 July 2018;
- (ii) ratification of the corporate actions approved and adopted by the Board of Directors during the year 2018;
- (iii) the Audited Financial Statements as of 31 December 2018;
- (iv) re-appointment of Sycip Gorres Velayo & Co. as external auditor of the Corporation.

(b) Organizational Meeting of the Board of Directors

Immediately after the stockholders meeting, the newly-elected directors held their organizational meeting.

(c) Other Matters

At the meeting which followed, the Board approved and adopted a resolution declaring cash dividends, as follows:
