

## SHAREHOLDINGS STRUCTURE

- The authorized capital stock of the Corporation is One Billion Pesos (₱1,000,000,000.00) divided into 600,000,000 common Class “A” shares, with a par value of One Peso (₱1.00) per share, and 400,000,000 common Class “B” shares, with a par value of One Peso (₱1.00) per share.
- Out of said authorized capital stock, 292,610,118 Common Class “A” shares, with an aggregate par value of Two Hundred Ninety-Two Million Six Hundred Ten Thousand One Hundred Eighteen Pesos (₱292,610,118.00), and 189,217,535 Common Class “B” shares, with an aggregate par value of One Hundred Eighty-Nine Million Two Hundred Seventeen Thousand Five Hundred Thirty-Five Pesos (₱189,217,535.00), have been subscribed and paid-up.
- There are no outstanding subscription receivables, all the shares subscribed having been fully paid.
- There are Four Hundred Twenty-Nine (429) Shareholders holding 100 shares or more. Four Hundred Thirty (430) are shareholders of Class A shares; Forty-Three (43) are shareholders of Class B shares; and Seven (7) are shareholders of both Class A and Class B shares.
